GUNN stated he had no information that indicated RUBY had known LEL HARVEY OSWALD prior to the assessination of the President.

GUNN adviced the only other persons who might have known RUT at the apartments were Mrs. BILL MARCUS, wife of the deceased owner of Continental Apartments; ROGER NAIL, pilot for Braniff Airlines who took his (GUNN's) place; or a Ballas premoter named PAUL (LNU), who had promoted the opening of the Gaslight Club, Dallas. CUNN advised this promoter had visited RUBY on many occasions at the apartments.
